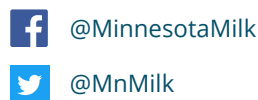

Eligibility

Open to any active milk producer in the state of Minnesota. This includes any person, family partnership, corporation or other entity that owns or leases from another party, dairy cows for the purpose of milk production. Every family member and/or employee receives benefits of membership.

Membership Types

There are two ways that you can pay your annual membership dues.

- \$0.01 (1 cent) per hundredweight of gross annual milk production paid once a year
- \$0.01 (1 cent) per hundredweight direct payment through creamery

Also note that 20% of your membership dues go toward direct lobbying expenses and is not tax deductible.
